Nomination form duly proposing and seconding a candidate, shall be received in the office between 5.00 & 7.00 p.m. The following schedule will be observed for the Elections:

**Counting of votes for the College Students' Union will start immediately after the polling is over.**

1. Students between the ages of 17 and 22 years as on 16<sup>th</sup> August of the year of election may contest elections.
2. The candidate should in no event have any academic arrears in the year of contesting the election. Any pending paper (s) will be construed as academic arrear(s). He should have passed all the papers that he/she appeared in.
3. The candidate should have attained the minimum percentage of attendance as prescribed by the University or 75% attendance, whichever is higher.
4. The candidate shall have one opportunity to contest for the post of office-bearer, and two opportunities to contest for the post of an executive member. No candidate can contest simultaneously for more than one post.
5. The candidate should not have a previous criminal record, that is to say, he should not have been tried and/or convicted of any criminal offence or misdemeanour. The candidate shall also not have been subjected to any disciplinary action by the University/College authorities.
6. The Candidates are required to submit the following documents alongwith their Application Forms:
  - (i) Copies of the 10<sup>th</sup> & 12<sup>th</sup> Class, 1<sup>st</sup> year & 2<sup>nd</sup> year Class Mark Sheets (as the case may be) and
  - (ii) Copies of the College Identity Cards and the latest fee receipt.

Only Students of II and III year classes are eligible to contest for the office of President, Vice-President, Secretary or Joint-Secretary.

**Only those students who have paid their fees upto Wednesday, the 10<sup>th</sup> September, 2025 are eligible to cast their votes.**

Candidates are requested to bring their Identity Cards and those of the proposer as well as the seconder while submitting their nomination forms.
